### **Due Diligence Process**

- An annual audit review of all of our suppliers & their processes.

- We expect all UK based suppliers to familiarise themselves with The Modern Slavery Act 2015 and our anti-slavery values and act consistently within these parameters.
- We ensure our whistleblowing policy is kept up to date and everyone is encouraged to report any concerns.
- We work to protect any vulnerable and exploited workers.
- We will continue to work with the Trade Associations to continuously improve our audit procedures and results.

### **Effectiveness & Communication**

Using our Company web-based software Activ we will measure the effectiveness of our policy & complete regular audits of our supply chain thru questionnaires, personal contact & site visits. This will help us to ascertain their understanding, compliance and set a standard of expectations.

We will provide any training where deemed necessary to help staff members monitor employee wellbeing and ensure no member of staff is exploited or made to feel vulnerable.

The Board of Directors will ensure effective communication of the policy throughout the Group companies and ensure all staff have a responsibility to prevent any slavery or human trafficking to occur.

### **Our Policy**

We have a zero-tolerance to modern slavery and human trafficking and we expect all those in our supply chain to comply with our values.

If a supplier is found to be operating with unacceptable practices they will be investigated and provided with guidance to remedy the situation. If no improvement is implemented or they indicate an unwillingness to cease the unacceptable practices then our trading relationship will cease with immediate effect and we will report them to the appropriate authorities.

Company policies within the Group of companies help us to assess, prevent and mitigate the risk of modern slavery existing in our organisation and its supply chains. These include:-
